This Privacy Policy explains how we collect, use, and protect your personal data when you visit www.selfempowermentfoundation.org.uk (“Website”).

We process personal data in accordance with the **UK General Data Protection Regulation (UK GDPR)** and the **Data Protection Act 2018**.

1. Who We Are

Self Empowerment Foundation is a not-for-profit initiative focused on supporting personal development, wellbeing, and empowerment through information, resources, and community engagement.

For the purposes of data protection law, Self Empowerment Foundation is the **Data Controller** of the personal data collected through this Website.

2. Personal Data We May Collect

We may collect and process the following personal information:

Information you provide directly

- Name
- Email address
- Contact details
- Messages submitted through contact forms
- Newsletter subscription details
- Donation information (if applicable)

Information collected automatically

- IP address
- Browser type and version
- Device information
- Website usage data through cookies or analytics tools

3. How We Use Your Data

We use your personal data for the following purposes:

- To respond to enquiries or messages
- To provide requested information or resources
- To send newsletters or updates (with consent)
- To manage donations or support
- To improve the functionality and performance of the Website
- To maintain the security of the Website

4. Lawful Basis for Processing

We process personal data under the following lawful bases:

- **Consent** – when you subscribe to communications or provide information voluntarily
- **Legitimate interests** – to operate and improve the Website
- **Legal obligations** – where required to comply with UK law

You may withdraw consent at any time.

5. How We Store and Protect Data

We take appropriate technical and organisational measures to protect personal data from unauthorised access, disclosure, or loss.

Personal data will only be retained for as long as necessary for the purposes for which it was collected.

6. Sharing of Personal Data

We do not sell or rent personal data.

However, we may share information with trusted service providers such as:

- Website hosting providers
- Email newsletter platforms
- Payment processors (for donations)

These providers process data only on our instructions and must comply with data protection regulations.

7. Your Data Protection Rights

Under UK GDPR, you have the right to:

- Access your personal data
- Request correction of inaccurate data
- Request erasure of your data
- Restrict or object to processing
- Request data portability
- Withdraw consent at any time
